

ORDINANCE NO. 79-4

AN ORDINANCE DECLARING A BRIDGE LOCATED IN CARIBOU COUNTY, IDAHO, IN SECTION 34, TOWNSHIP 7 SOUTH, RANGE 38 EAST, B.M., TO BE A HAZARD AND ORDERING THE SAME TO BE CLOSED TO ALL VEHICULAR AND PEDESTRIAN TRAFFIC, AND FURTHER ORDERING SAID BRIDGE TO BE REMOVED.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF CARIBOU COUNTY, IDAHO, AS FOLLOWS:

Section 1. The Board of County Commissioners of Caribou County, Idaho, does hereby determine that the use of that bridge located in Section 34, Township 7 South, Range 38 East, B.M., Caribou County, Idaho, which said bridge does cross the Portneuf River, is dangerous and constitutes a hazard to vehicular and pedestrian traffic, and that the same should be removed to prevent injury to persons or damage to property using said bridge, and that the repair of said bridge would constitute an unreasonable and burdensome expenditure for the taxpayers of Caribou County, Idaho.

Section 2. That said bridge which crosses the Portneuf River in Caribou County, Idaho, located in Section 34, Township 7 South, Range 38 East, B.M., is hereby closed to all vehicular and pedestrian traffic, and said bridge shall be removed as soon as is reasonably possible.

Section 3. The County shall cause appropriate warning signs to be posted at both ends of said bridge location wherein the same crosses the Portneuf River advising all users of the roadway leading to said bridge that said bridge is closed to vehicular traffic and pedestrian traffic, and upon said bridge being removed shall place appropriate warning signs or obstructions in said roadway to warn all users of said roadway that said bridge has been removed.

Section 4. This ordinance shall be in full force and effect from and after it's passage, approval, and publication according to law

CLOSING OF COUNTY ROAD AND COUNTY BRIDGE

WHEREAS, the County of Caribou, State of Idaho, seeks to close a bridge located in Section 34, Township 7 South, Range 38 East, B.M., where said bridge crosses the Portneuf River, in Caribou County, Idaho, and

WHEREAS, the undersigned do so desire that said bridge be closed as the same is in an unsafe condition and constitutes a danger to vehicular traffic, and

WHEREAS, the undersigned, upon requesting said bridge to be closed to vehicular traffic, do further desire to waive and forego any right to compensation which they may be entitled to from the County of Caribou, State of Idaho, for the closing of said bridge, or for damages resulting from said closure to property owned by the undersigned furnished access by said bridge and roadway.

NOW, THEREFORE, the undersigned to hereby specifically request that that bridge located in Section 34, Township 7 South, Range 38 East, B.M., crossing the Portneuf River located in Caribou County, Idaho, be closed to all vehicular traffic, as the same is unsafe and unsuitable for the same, and constitutes a hazard and danger to vehicles seeking to cross said bridge. The undersigned further forego and release the County of Caribou, State of Idaho, for any compensation to the undersigned as a result of said closure, and do further waive any right to compensation for damages accruing to the undersigned or to their property as a result of said closure. It is understood that the County of Caribou, State of Idaho, will cause a load of gravel to be deposited upon the roadway west of the bridge to be closed in order to facilitate vehicular traffic for the undersigned on said roadway west of the bridge.
