

ORDINANCE NO. 84-2

AN ORDINANCE ADOPTING A MAP IDENTIFYING AN AREA OF CITY IMPACT WITHIN THE UNINCORPORATED AREA OF CARIBOU COUNTY, IDAHO, FOR THE CITY OF GRACE, IDAHO.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF CARIBOU COUNTY, IDAHO, AS FOLLOWS:

Section 1: That the Board of County Commissioners of Caribou County, Idaho, does hereby adopt an area of city impact for the City of Grace, Idaho, within the unincorporated areas of Caribou County, Idaho, described as follows:

Beginning at the Northeast Corner of Section 30, Township 9 South, Range 41 East, B.M.; thence running West to the Northwest Corner of Section 26, Township 9 South, Range 40 East; thence running South to the Southwest Corner, Section 2, Township 10 South Range 40 East; thence running East to the point of intersection of the Turner Road and the Bear River; thence running in a Southwesterly direction along Bear River to the West boundary line of Section 11, Township 10 South, Range 40 East; thence running South to the Southwest corner, Section 14, Township 10 South, Range 40 East; thence running East to the Southeast Corner, Section 16, Township 10 South, Range 41 East; thence running in a Northerly direction along the West boundary line of the National Forest bordering the proposed area of City Impact to the point of beginning.

Section 2: That the map attached hereto as "Exhibit A" is hereby adopted and made part of this ordinance as identifying said area of impact of the City of Grace, Idaho, as if set forth herein.

Section 3: That said area of city impact is adopted pursuant to the provisions of §67-6526, Idaho Code, and following the notice and public hearing provisions as set forth in §67-6509, Idaho Code, the notice having been published pursuant to law.

Section 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5: This ordinance shall be in full force and effect from and after the date of publication.


