

ORDINANCE NO. 93-02

AN ORDINANCE OF THE COUNTY OF CARIBOU, STATE OF IDAHO, ESTABLISHING SPEED LIMITS AT 35 MILES PER HOUR FOR ALL MOTOR VEHICLES TRAVELING ON THIRD EAST STREET NORTH TO GOVERNMENT DAM ROAD; ON GOVERNMENT DAM ROAD TO THE NORTH END OF HOOPER SPRINGS PARK; AND ON THAT STREET WHICH CONNECTS HIGHWAY 34 TO THE INTERSECTION OF THIRD EAST STREET AND GOVERNMENT DAM ROAD; AND ON THAT HIGHWAY KNOWN AS BASIN ROAD BETWEEN THE POINT WHERE SAID ROAD INTERSECTS WITH KELLY TOPONCE ROAD AND RESERVATION ROAD; ESTABLISHING THE SPEED LIMIT FOR ALL VEHICLES ON SAID ROADS AS 35 MILES PER HOUR; ESTABLISHING A PENALTY FOR VIOLATION THEREOF; AND ESTABLISHING AN EFFECTIVE DATE FOR THIS ORDINANCE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF CARIBOU COUNTY, IDAHO, AS FOLLOWS:

Section 1: No person shall drive a motor vehicle at a speed in excess of 35 miles per hour on that portion of Third East Street from the city limits of Soda Springs, Idaho, North to where said street intersects with Government Dam Road located on the North boundary line of Section 6, Township 9 South, Range 42 East, B.M., Caribou County, Idaho, or at a speed in excess of 35 miles per hour from the intersection of East Third Street and Government Dam Road West on Government Dam road along the North boundary line of said Section 6, Township 9 South, Range 42 East, B.M., and thence Northerly on said Government Dam Road through Section 31, Township 8 South, Range 42 East, B.M. on the West boundary line of said Section 31 North to the North end of Hooper Springs Park; or at a speed in excess of 35 miles per hour on County Road 50 E which runs from Highway 34 in a Westerly direction along the South boundary line of Section 31, Township 8 South, Range 42 East, B.M. to the intersection of Government Dam Road and Third East Street, located in Caribou County, Idaho.

Section 2: No person shall drive a motor vehicle at a speed in excess of 35 miles per hour on Basin Road, commencing at a point where said road intersects with Kelly-Toponce Road then running in a North/Northwest direction through Sections 25, 24 and 23, Township 6 South, Range 38 East, B.M., to a point where said road intersects with a road running in a North/South direction known as Reservation Road, located in Caribou County, Idaho.

Section 3: Any person violating this Ordinance shall be guilty of an infraction and shall be subject to those fines and penalties as set forth by state statute for infractions.

Section 4: This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law, and the erection of traffic control devices along said roadways which set forth the speed limit established herein.
