AN ORDINANCE ADOPTING A MAP IDENTIFYING AN AREA  
OF CITY IMPACT WITHIN THE UNINCORPORATED AREA  
OF CARIBOU COUNTY, IDAHO, FOR THE CITY OF SODA  
SPRINGS, IDAHO.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS of  
Caribou County, Idaho, as follows:

Section 1. That the Board of County Commissioners of  
Caribou County, Idaho, does hereby adopt an area of city  
impact for the City of Soda Springs, Idaho, within the  
unincorporated area of Caribou County, Idaho, described as  
follows:

Beginning at the  $W\frac{1}{2}$  Corner of Section 24, Township  
9 South, Range 41 East, B.M.; thence North along  
West line of Sections 24, 13 & 12 to the  $W\frac{1}{2}$  Corner  
of Section 12, thence West along the East-West mid-  
section line of Section 11 to the SW corner  $SE\frac{1}{2}NE\frac{1}{2}$   
Section 11; thence North along the West line of the  
 $E\frac{1}{2}NE\frac{1}{2}$  Section 11 and the West line of the  $E\frac{1}{2}$  of the  
 $E\frac{1}{2}$  of Section 2 to the North line of Section 2; thence  
East along the North line of Section 2, and Section  
1, Township 9 South, Range 41 East, B.M., and Section  
6 and Section 5, Township 9 South, Range 42 East  
B.M. to the NE corner of Section 5; thence South  
along the East line of Sections 5, 8, 17 and 20 to the  
 $E\frac{1}{2}$  Corner of Section 20; thence West along the East-  
West mid-section line of Sections 20 and 19, Township  
9 South, Range 42 East, B.M. and Section 24, Township  
9 South, Range 41 East, B.M. to the  $W\frac{1}{2}$  corner  
Section 24 and the point of beginning.

Section 2. That the map attached hereto as "Exhibit A"  
is hereby adopted and made part of this ordinance as identifying  
said area of city impact of the City of Soda Springs, Idaho,  
as if set forth herein.

Section 3. That the said area of city impact is adopted  
pursuant to the provisions of §67-6526, Idaho Code, and  
following the notice and public hearing provisions as set  
forth in §67-6509, Idaho Code, the notice having been published  
in the Caribou County Sun, Soda Springs, Idaho, on May 18,  
and June 1, 1978.

Section 4. All ordinances or parts of ordinances in  
conflict herewith are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after the date of publication.

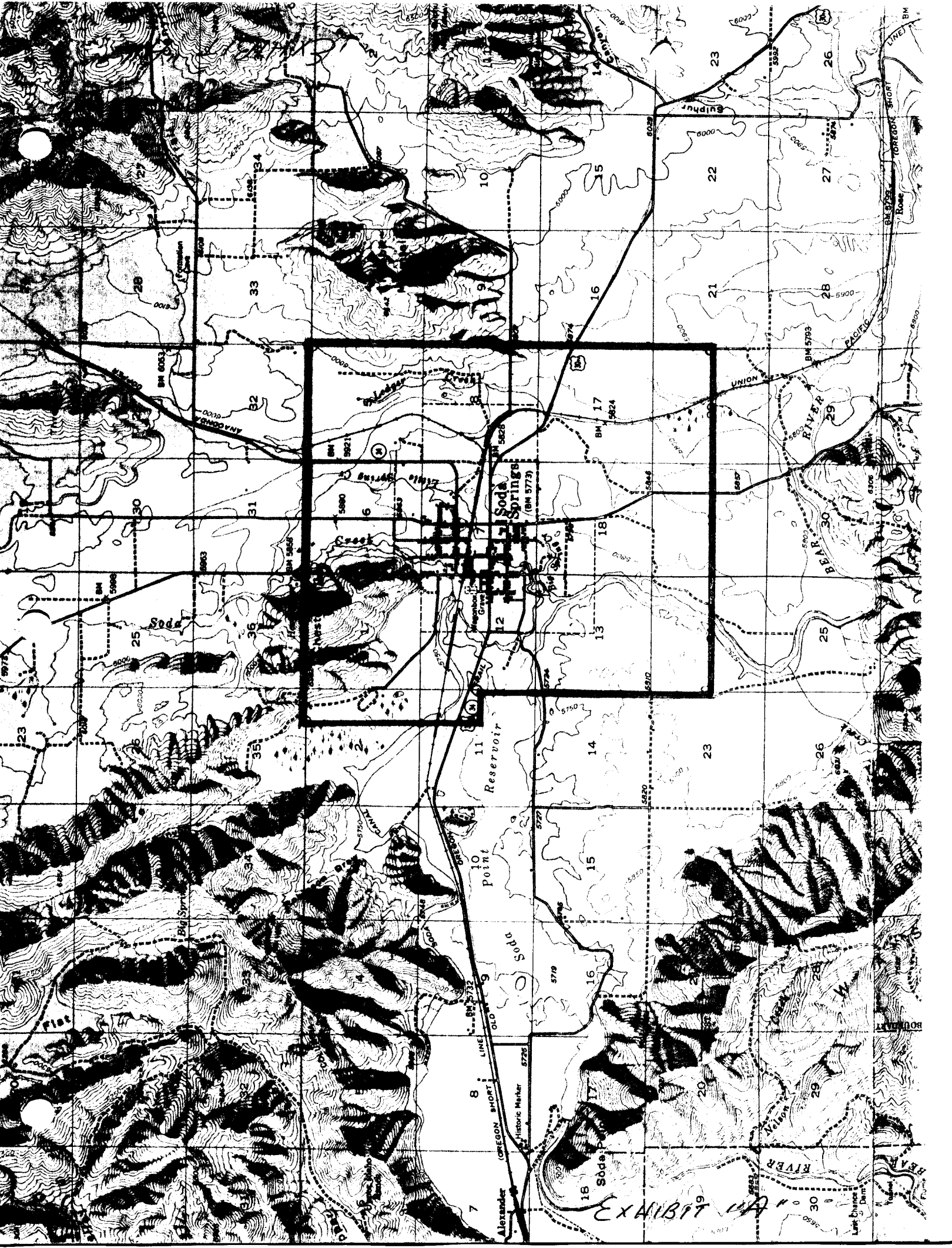
