

ORDINANCE NO. 80-2

WHEREAS, one David Alan Doerr of the Cedar View Subdivision, Caribou County, Idaho, did file a petition with the Board of County Commissioners of Caribou County, Idaho, to vacate the turn around space located in Lot 10 of the Cedar View Subdivision, said turn around space being more particularly described as follows:

Beginning at a point on the Southeast Corner of Lot 10, Cedar View Subdivision, Caribou County, Idaho, thence North  $54^{\circ}62'$  West 66.95 feet; thence North  $8^{\circ}48'$  East 138.22 feet; thence South  $45^{\circ}45'$  East 73.65 feet; thence South  $82^{\circ}42'$  West 125.20 feet to the point of beginning.

WHEREAS, the Board of County Commissioners did cause notice of said petition to be posted in three public places within Caribou County, Idaho, and also within the limits of said acreage to be vacated, and further did cause said notice to be published in the Caribou County Sun, Soda Springs, Idaho, once a week for two successive weeks according to law, and

There being no opposition made to such petition or application within 30 days after said posting and publication, and there appearing to be no reason why said turn around space should not be vacated,

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Caribou County, Idaho, as follows:

1. That the turn around space located in Lot 10, Cedar View Subdivision, Caribou County, Idaho, official plat of which is on file in the office of the County Recorder of Caribou County, Idaho, is hereby vacated. The turn around space is more specifically described as follows:

Beginning at a point on the Southeast Corner of Lot 10, Cedar View Subdivision, Caribou County, Idaho, thence North  $54^{\circ}62'$  West 66.95 feet; thence North  $8^{\circ}48'$  East 138.22 feet; thence South  $45^{\circ}45'$  East 73.65 feet; thence South  $82^{\circ}42'$  West 125.20 feet to the point of beginning.

2. That said turn around space shall hereby vest in the adjoining property owner or owners according to Section 50-311, Idaho Code, and that the Board of County Commissioners has determined that the only adjoining land owner of said turn

around space is the said David Alan Doerr of Caribou County,  
Idaho.

3. This ordinance shall be in full force and effect  
from and after the date of its publication according to law,  
and after the same has been filed in the office of the  
County Recorder of Caribou County, Idaho, in the same manner  
as other instruments affecting the title to real property.
