ORDINANCE NO. <u>95-03</u>

AN ORDINANCE OF CARIBOU COUNTY, IDAHO, ESTABLISHING FEES FOR THE USERS OF SOLID WASTE DISPOSAL FACILITIES WITHIN CARIBOU COUNTY, IDAHO; PRESCRIBING THE AMOUNT OF SAID FEES; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; AND ESTABLISHING AN EFFECTIVE OF THIS ORDINANCE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF CARIBOU COUNTY, IDAHO, AS FOLLOWS:

<u>Section 1:</u> Section 31-4404, Idaho Code, permits the Board of County Commissioners to collect fees from the users of solid waste disposal facilities in order to properly establish, maintain, and operate solid waste disposal facilities within Caribou County thereby reducing the threat to health posed by uncollected garbage, refuse and scrap and for the purpose of maintaining the natural and aesthetic setting of the land, water, and air resources within the county, and for such other cultural, social, economic and sanitation reason as may be necessary from time to time.

<u>Section 2:</u> The annual fee hereby established for solid waste disposal within Caribou County, Idaho, for the 1995-1996 fiscal year, commencing October 1, 1995, and terminating on September 30, 1996, shall be as follows:

Circuit breaker	
(in accordance with Idaho Code)	\$ 25.00
Family residence	\$ 65.00
Small business	\$ 95.00
Industrial and large business	\$195.00
Apartment house (max. 5 units)	\$ 65.00
Apartment house - each additional unit	\$ 15.00

Section 3: The prior rates established in 1992 shall remain in effect through September 30, 1995, those being:

Circuit breaker	\$ 25.00
Family residence	\$ 50.00
Small business	\$ 75.00
Industrial and large business	\$150.00
Apartment house (max. 5 units)	\$ 50.00
Apartment house - each additional unit	\$ 10.00

<u>Section 4:</u> Those dwellings or structures with a net market value of \$2,000.00 or less shall be exempt from the fees prescribed in this ordinance.

<u>Section 5:</u> There is hereby certified against each of the above mentioned properties a special assessment on each of the properties served for the above stated amounts, and the Assessor is authorized to place the same upon the notice of taxes, and the County Treasurer and Tax Collector is hereby authorized and empowered to collect the same as if the same were taxes.

<u>Section 6:</u> All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 7: This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
